

DECISION STATEMENT ON THE INDEPENDANT EXAMINERS REPORT – SWANTON MORLEY NEIGHBOURHOOD PLAN

1. INTRODUCTION

In accordance with Regulation 18(2) of the Neighbourhood Planning (General) Regulations 2012 (as amended), Breckland District Council have produced this 'Decision Statement' in relation to the Swanton Morley Neighbourhood Development Plan (the Plan).

2. DECISION

Following an independent examination on the Plan, Breckland District Council (BDC) has considered each of the recommendations made by the examiner and the reasons for them. In deciding what action to take, all those proposed by the independent examiner in his report are accepted (as required by section 12, para (2)), Schedule 4B, 1990 Town and Country Planning Act (TCPA)), except seven (PM6, PM7, PM8, PM10, PM11, PM19 & PM23 listed in Appendix of the Examiners Report). The details of these decisions are found in the Decision Report on the website below.

Following a further screening exercise under the Habitat Regulations, this identified that an Appropriate Assessment was required. The assessment identified that a further amendment to Policy 14 was required in order to pass this assessment. The details of this change can be found in the Habitat Regulations Assessment - Screening Report with the Appropriate Assessment (December 2018) on the website below.
