The RSPB supports the additions made to this policy. However, there is one important proposed deletion that we do not support and without it being amended accordingly, we do not considered that the plan can be considered justified based on the established peer-reviewed evidence regarding the effects of trunk roads on Stone Curlews. This is the same evidence-base that has shaped the inclusion of the 1500m buffer around the Breckland SPA.

## Please set out what changes you consider necessary to make the proposed main modifications to the Local Plan legally compliant or sound.

On page 105, paragraph 4 has "and roads" struck out. This has to be reinstated and written as "...and trunk roads..." in accordance with the research that highlights the negative associations Stone Curlews show with main arterial routes.

### Please give us details as to why you think the Local Plan with proposed modifications is NOT legally compliant or sound?

The two new paragraphs suggested for insertion on pages 109 and 110 respectively are contradictory. The former states that LSE <u>can</u> be concluded beyond the 1500m buffer, whilst the latter suggests that a project level assessment may be necessary for large developments.

In order to be considered justified, the formation of these two paragraphs should be reset to provide clarity for the plan-user.

### Please set out what changes you consider necessary to make the proposed main modifications to the Local Plan legally compliant or sound.

We suggest that "can" is altered to "may probably" in the first line of the 3rd para on page 109:

"A conclusion of no likely significant effect <u>may probably</u> be met where the proposed building is located further than the 1500m away from the SPA boundary (red primary buffer) or the identified (blue secondary buffer) or possible (orange square cells) areas that have a functional link (see Map 5.1)."

It should not be definitive that LSE can be concluded. Leaving the wording as presented will not be in keeping with the overall spirit of the policy which is so positively set to conserve <u>and enhance</u> biodiversity. To say that LSE can be concluded for any projects just outside the buffer will, by implication, potentially limit the expansion and recovery of Stone Curlew populations around the Brecks and abrogate any responsibility for an applicant to consider conducting an HRA in the future should the population have increased.
