## BRECKLAND COUNCIL LOCAL GOVERNMENT ACT 2000 THE LOCAL AUTHORITY (MEMBERS' ALLOWANCES) (ENGLAND) REGULATIONS 2003

Breckland Council adopted a new scheme of allowances for councillors for the period 1st April 2021–31st March 2023, subject to any increase in line with the annually agreed Breckland staff settlement.

The scheme follows the recommendations of an Independent Remuneration Panel.

An annual basic allowance of £5,780.00 payable to all 49 Members.

Special responsibility allowances (a maximum of one claimable per member) payable to the holders of the following positions at the annual rates indicated below. There is an option for Members not to claim allowances in part or in full.
