Proposals for appropriate on-site storage and run off rates will be expected to meet the standards set in technical guidance issued by Norfolk County Council as LLFA and as set out in DEFRA's Non-Statutory Standards for Sustainable Drainage, the CIRIA SuDS Manual and other relevant codes of practice. Applicants are also encouraged to have regard to the local guidance, set out in the Saham Toney Sustainable Drainage Systems Design Manual.***
