#### 1.0 Introduction

We understand that domestic abuse is a serious issue that has a widespread impact on individuals and families in our community. If you or someone you know is currently experiencing domestic abuse, this information will inform you about the support available and how you can get in touch.

Please remember, if you are ever in immediate danger, contact 999.

Breckland Council is committed to providing the support needed to create a safe environment for individuals and families. We will listen to your experiences with empathy and understanding, without any judgement. We have professionals who are ready to help you through the challenges and create a positive impact on you and your family's life.

#### 2.0 What is domestic abuse?

Breckland Council recognises and acknowledges the legal duties and obligations under legislation relating to domestic abuse and the importance of ensuring that support services for those experiencing domestic abuse are accessible.

#### Legal definition of domestic abuse

Domestic abuse involves any single incident or pattern of conduct where someone's behaviour towards another is abusive, and where the people involved are aged 16 or over and = are, or have been, personally connected to each other (regardless of gender or sexuality).

The abuse can involve, but is not limited to:

- psychological
- physical
- sexual
- financial
- emotional
- violent
- threatening
- controlling
- coercive behaviour. 'Personal connection' means the individuals concerned:
- are due to be, are currently, or have been, married or civil partners to each other
- are, or have been, in an intimate personal relationship with each other
- are, or have been, parents (or had a parental relationship) to the same child
- are relatives (the Act gives further definitions of 'relatives')

# Reference: Sections 1 and 2 of the Domestic Abuse Act 2021

Children are recognised as victims of domestic abuse in their own right if they see, hear or experience the effects of abuse between two personally connected

individuals who are aged 16 or over. However, abusive behaviour directed at a person under the age of 16 is child abuse rather than domestic abuse.

## **Physical abuse**

Includes: assault, hitting, slapping, pushing, kicking, misuse of medication, being locked in a room, inappropriate sanctions or force-feeding, inappropriate methods of restraint, and unlawfully depriving a person of their liberty.

## **Controlling Coercive Behaviour**

Coercive Control is a form of domestic abuse that became a criminal offence in 2015 It is an act or a pattern of acts of assault, threats, humiliation and intimidation or other abuse that is used by perpetrators to harm, punish, or frighten their victim. These behaviours are designed to make the victim dependent on the perpetrator, removing their independence, isolating them from support networks, and controlling their everyday behaviour and activity

#### **Sexual Abuse**

Includes rape, indecent exposure, sexual harassment, inappropriate looking or touching, sexual teasing or innuendo, sexual photography, subjection to pornography or witnessing sexual acts, indecent exposure and sexual assault or sexual acts to which the adult has not consented or was pressured into consenting

## **Image Based Abuse (Revenge Porn)**

Distribution or threat of distribution of private images/videos without consent with the intention of causing embarrassment and distress

#### Psychological, Emotional or other abuse

Involves the regular and deliberate use of a range of words and non-physical actions used with the purpose to manipulate, hurt, weaken, or frighten a person mentally and emotionally; and/or distort, confuse or influence a person's thoughts and actions within their everyday lives (Gaslighting).

#### **Economic abuse**

Economic abuse is and can include restricting access to essential resources such as food, clothing and transport. Creating a dependency by denying the means to

improve a person's economic status – for example through education, employment, access to benefits or training.

We treat all reports of domestic abuse with respect, sympathy, and in confidence. We understand that reaching out for help in cases of domestic abuse can be an immensely challenging step and we are here to provide a safe environment for all individuals affected by or experiencing domestic abuse.

The safety and well-being of those affected by or experiencing domestic abuse is our top priority. Breckland Council works with partner agencies to provide support and ensure that contact can be made safely. We can arrange for a safe time, place, or communication method that is convenient and accommodate any special measures that might be required.

#### **Housing Support and Guidance**

Our team can provide you with both support and guidance. We have invested into our staff with training to be able establish the risks and challenges that could be faced. We recognise that each person will require different support throughout their journey away from domestic abuse.

## **Breckland Council Sanctuary Scheme**

We understand that some people may wish to remain in their current home, and where appropriate to do so, Breckland Council can support this. The Sanctuary Scheme aims to improve home security and safety for those affected by domestic abuse by making physical changes to the property.

#### **Housing Options and Safe Accommodation**

We understand that domestic abuse is different for everyone, and some options may not be suitable for all individuals. Our team will explain decisions and will ensure that the safety of those affected by or experiencing domestic abuse is our top priority.

There are different types of housing support available, and if suitable, these will be explained and explored.

**Temporary Accommodation / Safe Accommodation:** Provided by Breckland Council if a person or family becomes homeless and urgently need a home.

**Refuge Accommodation:** Refuges offer accommodation and intensive support. If this is suitable, this will be discussed with you.

**Move-on and / or Second Stage Accommodation:** These are interchangeable terms for projects temporarily accommodating survivors, including families who no longer need the intensive level of support provided in a refuge, but would

still benefit from a lower level of domestic abuse specific support for some time, before they move to fully independent and permanent accommodation.

**Specialist Safe Accommodation:** Specialist refuges for ethnically diverse communities, Lesbian, Gay, Bisexual, Transgender Questioning and other ("LGBTQ+") communities, and disabled survivors and their children. These may provide single sex or gender accommodation with dedicated specialist support to survivors who share a protected characteristic(s).

This includes services that are led by those that also share the protected characteristics and/or have complex needs.

## **Further Help from Breckland Council**

If you are receiving support from other departments within Breckland Council, and if appropriate, our teams can work together to provide you with the best possible support. We are able to make a number of referrals to both external and internal professionals who can assist with debts, financial guidance, legal aid, and emotion and well-being support.

## **Family Support and Children**

Under the Domestic Abuse Act 2021, children who have seen, witnessed or experienced the effects of domestic abuse will also be considered survivors of domestic abuse. This recognises the long-lasting impacts of domestic abuse and aims to ensure that specific support for children and young people is available.

We acknowledge the impact that domestic abuse can have on a family and understand that there can be concerns about having to leave support networks, friends and schools. This can also be a significant barrier preventing someone leaving an abusive relationship.

Breckland Council understands that each person may have different preferences and circumstances. These are some of the things that we will do to help support families and children:

- Referrals for family members for appropriate support and options to review different courses focused on recovery for survivors of domestic abuse.
- We offer explanations of housing options and provide debt advice services. These can be discussed with the Housing Options Team if required. Our team will also consider the needs of children and young

people when exploring housing options and any additional support that may be needed.

#### 4.0 Perpetrator Management

Breckland Council is committed to ensuring that communities and families are safe and will take a number of measures to ensure that correct procedures are followed and upheld when managing cases of domestic abuse. We understand that not all people who speak with us will wish to have information shared with or reported to the police and may wish to remain in a relationship with the perpetrator. Our decisions regarding support will be based on the specific risks identified by professionals using risk assessment tools and information from any historical incidents. Breckland Council will also be guided by any safeguarding concerns that Independent Domestic Abuse Advisory Services may have regarding a person's situation or judgement.

Breckland Council aims to respect the wishes of survivors and any information that is shared with us, we have a responsibility to report and act upon all cases of abuse, regardless of the survivors wishes, in situations where:

- a) There are any concerns for the safety of a child.
- b) There are concerns for the safety of an adult.
- c) There are immediate safety concerns.
- d) There are identifiable indicators of risk of serious harm; potential event could happen at any time and the impact would be serious. Risk which is life threatening and/or traumatic.

We acknowledge that Breckland Council will work with perpetrators of domestic abuse regarding housing advice and options. We will also ensure that information and support are available to perpetrators who wish to address their behaviour and offer to review services and provide signposting for each individual circumstance.

Breckland Council will work closely with specialist domestic abuse and partner agencies when counter-allegations of abuse are made, to assist with identifying the primary perpetrator and to ensure the right support is put in place for the survivor.

## **Perpetrator Accountability**

Breckland Council has duty to ensure the safety of those within the community and this can include monitoring any risks that a person might present.

In cases of domestic abuse in which information has been shared by the police, health service or other professionals indicating that domestic abuse has taken place, Breckland Council must consider the safety of the survivor and any other persons. This could include when reviewing housing options or temporary accommodation, as we have a duty to safeguard residents.

As part of our commitment to Prevention and Awareness:

- We will continue to work closely with our professional partners in domestic abuse to ensure that we are providing the best possible support and services.
- We will continue to raise awareness within our organisation and maintain events in which all staff members can learn more about the impacts of domestic abuse, as well as recognising and preventing it.
- We will continue to maintain and monitor the domestic abuse training provided to our staff, ensuring that the organisation receives ongoing domestic abuse awareness training and that refresher courses are completed by those already working for Breckland Council.
- We will continue our partnership with the <u>Daisy Programme</u>, a local charity which supports people who have experienced domestic abuse.
- We will continue to meet our statutory safeguarding requirements in line with our existing policies and procedures whenever there are safeguarding concerns about a resident or family.
