### 1. Process Narrative


- 1.1. At the 14<sup>th</sup> November 2015 Village Consultation Event it rapidly became clear that the gap between Yaxham and Dereham, defined by the Tud River Valley, was and is a critical factor in defining the separateness, independence and identity of the small rural parish of Yaxham from the large urban market town of Dereham to the north (see Consultation Statement, Appendix 2 Previous Consultations).
- 1.2. From this event and consultation responses it became clear to the Working Group that developing the Strategic Gap policy was of great importance to the residents of Yaxham. That importance grew with the publication of the Emerging Breckland Local Plan Consultation documents in December 2015 with recommendations for significant expansion of Dereham to the south towards the parish boundaries, including with Yaxham (see Section 2. below), combined with planning applications covering most of this land under consideration for over 500 new homes (3PL/2015/1490/O, 291+New dwellings, 3PL/2010/1381/F, 255 New Dwellings)
- 1.3. In addition during the November 2015 Consultations it was clear that the Yaxham settlement of Clint Green equally did not want to have development closing the gap with the much larger village of Mattishall to the east.
- 1.4. Whilst the Working Group recognised that the NP4Yaxham could only apply to areas within Yaxham's Parish Boundary, it was seen as only one part of the story. So the initial draft policy maps did extend beyond the Yaxham parish boundary (see 6.4-6.7 below). It appeared self-evident that only that within the Parish was covered by NP4Yaxham, but it quickly became apparent that others did not appreciate this, and so the indicated gaps were kept to the parish boundary, but supplemented by Parish Action Point PAP1 calling for Yaxham to work with other Parish Councils and Neighbourhood Plan Working Groups to see if similar could be included in their Neighbourhood Plans. This latter point is an aspiration and not a land use policy.
- 1.5. Strategic Gap 1 developed from the imminent challenge of development within the defining Tud River Valley (see 2.3 below). A previous Yaxham Parish Chairman relates that Breckland Officers in the past said "Don't worry, George, they'll never be allowed to develop in the Tud River Valley", and here we were facing the extension of Dereham south into that valley threatening to result in the coalescence of the two settlements. One of the Regulation 14 Consultation responses explicitly talks about Yaxham should be considered for more development because it and Dereham are "linked-settlements" (<a href="https://www.np4yaxham.com">www.np4yaxham.com</a>). The Strategic Gap 1 is designed precisely to prevent such a coalescing. The Maps in Attachment 1 show how this evolved through to the recent versions that centred on the River Tud Valley, and the Regulation 16 Map which combines the contour lines of the valley, use of identifiable geographical features and sight-lines across the valley (See Section 3.), based on extensive field-work, including many hundreds of photographs. The sight-lines approach was eventually suggested by Breckland Council in its Regulation 14 formal response which the Working Group took on-board and this resulted in the


- current version of Strategic Gap 1. These Maps also include an indication of where the two planning applications are located, further eroding the Dereham side of the gap between Dereham and Yaxham, hence the need to reinforce the gap from within the Yaxham parish to prevent coalescence with Dereham.
- 1.6. Strategic Gap 2 reflects the residents of Clint Green strongly expressed desire to retain its clear distinction from the neighbouring much larger village of Mattishall. This follows recognised geographical features providing an anti-coalescence buffer between Clint Green and the Yaxham parish boundary (see Section 4. below).
- 1.7. Strategic Gap 3 emerged from the 27th January Village Consultation Event that was used to test out the emerging policies. Reaction at that event was why was there not a Gap included to protect the clearly separate and independent settlements of Yaxham and Clint Green and to therefore prevent their coalescence. This was included in the Working Group's emerging Breckland Local Plan Consultation response in February 2016. Its final form makes use of both sight-lines and geographical features on the ground to provide certainty as to where the gap boundary applies (see section 5. below).
  - 1.8. All three Strategic Gaps were included in the Working Group's emerging Breckland Local Plan Consultation response in February 2016 and were expressly approved by the Yaxham Parish Council meeting of 11th February 2016 (<a href="http://www.yaxham.com/pages/Minutes">http://www.yaxham.com/pages/Minutes</a>). This was the "Trapezoid" shaped Gaps map (see 6.4 below).
- 1.9. In the first informal submission of the draft NP4Yaxham to Breckland Council on 23<sup>rd</sup> February 2016, the Gaps were restricted to Yaxham Parish, and followed settlement outlines and the Td River Valley. Through a formatting error these appeared as solid blocks which did not assist with understanding (see 6.3 below)
- 1.10. Various other versions of mapping were tried in order to achieve the objective of preventing coalescence, of which the flood-based map was an example (see 6.2 below). Variations were included in consultations and newsletters. The next evolution of the map was included in the Regulation 14 Pre-submission. It followed contour lines, but did not give clarity of where a boundary would actually be on the ground. Breckland Council suggested sight-lines and field work, and revising the extent of the area covered by the Gaps. This is the work the Working group has undertaken, which makes up the bulk of this document, and fed through to the current version of the Gaps included in the Plan for Regulation 16 consultation.
- 1.11. The following maps and aerial views show first the context and fieldwork including sight-lines, cross-sections and photographs. In addition, Section 6 shows the evolution of the Gap maps prior to the Regulation 16 Plan.

NB Please note photos were taken during late spring/early summer 2016 when the trees and foliage were at their most verdant.







































### 6.2. April 2016 - Flood Map Based Approach






