

Equality Impact Assessment of the Breckland Local Plan (2011-2036)

1. Introduction

- 1.1 This report sets out the results of the Equality Impact Assessment (EqIA) of the Breckland Local Plan. The report sets out the likely impact of policies within the Local Plan on those groups who have protected characteristics defined through the Equality Act (2010).
- 1.2 The need for an EqIA to be undertaken stems from the duty placed on public authorities to eliminate unlawful discrimination in carrying out its functions, and promote equality of opportunity between men and women, different racial groups and other equality groups. The equality duty is intended to support good decision-making by ensuring that public bodies consider how different people will be affected by their activities, helping them deliver policies and services which:
 - Are efficient and effective;
 - Are accessible to all; and
 - Meet different people's needs
- 1.3 The Equality Act covers nine protected characteristics which cannot be used as a reason to treat people unfairly. Every person has one or more of the protected characteristics, so the act protects everyone against unfair treatment. The protected characteristics area:
 - Age
 - Disability
 - Gender reassignment
 - Marriage and civil partnership
 - Pregnancy and maternity
 - Race
 - Religion or belief
 - Gender
 - Sexual orientation
- 1.4 The Equality Act sets out the different ways in which it is unlawful to treat someone such as, direct and indirect discrimination, harassment, victimisation and failing to make a reasonable adjustment for a disabled person.
- 1.5 A key measure in the Act us the public sector Equality Duty, this seeks to ensure that all public bodies play their part in making society fairer by tackling discrimination and providing equality of opportunity for all.
- 1.6 The Equality Duty is set out in section 149 of the Act. The Equality Duty has three aims, and requires public bodies to have due regard to the need to:
 - Eliminate unlawful discrimination, harassment, victimisation and any other conduct that is prohibited by the Act;
 - Advance equality of opportunity between people who share a protected characteristic and people who do not share it; and

• Foster good relations between people who share a protected characteristic and people who do not share it.

2. Assessing the baseline

- 2.1 The Sustainability Appraisal forms a good source of baseline data on the characteristics within the District. In addition to this the Census also forms a good source for information. For this reason it is not considered necessary to repeat the information here.
- 2.2 Through the sustainability appraisal objectives a number of the protected characteristics have been had regard to in the formulation of policies within the Local Plan and this forms a starting point for consideration of the EqIA.

3. Assessment of policies

- 3.1 The Breckland Local Plan contains 82 policies. All of the policies have been assessed against any impact upon the different groups as identified in the Equalities Act 2010. The high level decision making questions used for the EqIA are: *Is there a likely simpact on the groups identified?* and *Have the needs of the identified groups been addressed?*
- 3.2 The assessment uses the following symbols to identify the potential impact of each policy on each protected characteristic.
